INTRODUCTION

This blog describes the disturbing discrimination since 2014 in the allocation of funds by the Good Will Foundation (GWF), a fund created to distribute funds restituted by the Lithuanian government for pre-World War II Jewish RELIGIOUS Communal property.

Chabad Lithuania has NOT received any funds from the GWF to date, despite numerous requests, and despite doing the vast majority of RELIGIOUS Jewish work throughout Lithuania for the past two decades.

Chabad Lithuania has also been excluded from having even one voice on the GWF board, and our numerous requests for details of funds received and spent have been ignored for more than half a year.

More Disturbing: Lithuanian Jewish Community (LJC) leadership sabotaging efforts of Chabad Lithuania for control of restitution funds.
