

# DOCUMENTATION OF SEIMAS VOTE RELATING TO DRAFT RESOLUTION XVP-1629

23 June 2026 · Lithuanian Seimas

## Purpose of this note

This note records objective information retrieved on 11 July 2026 from pages on the official website of the Seimas of the Republic of Lithuania (Irs.lt). The relevant Seimas URLs were returning “404 Not Found” when accessed by the researcher from the United Kingdom, but the official pages and their indexed text were retrievable through web search. This document is therefore a research record and transcription of the official Seimas material; it is not an original Seimas PDF, screenshot, or certified parliamentary document.

## Identification of the draft

## Official Seimas record of the procedural vote

The official Seimas sitting record gives the following entry at 10:12:29 on 23 June 2026:

“**Vykė balsavimas dėl pasiūlymo išbraukti iš darbotvarkės projektą Nr. XVP-1629; pritarta (už 68, prieš 16, susilaikė 25).”**

**English translation:** “A vote took place on the proposal to remove Draft No. XVP-1629 from the agenda; the proposal was approved (68 for, 16 against, 25 abstained).”

## What the vote establishes

The recorded vote was on a proposal to remove XVP-1629 from the agenda. It was not a vote on adoption of the draft resolution on its merits. The proposal to remove the draft was approved by 68 votes to 16, with 25 abstentions.

A separate official Seimas statistics page identifies XVP-1629 by the same Lithuanian title and shows the later database status “Atmestas” (“Rejected”), dated 7 July 2026. That database classification should be distinguished from the wording of the 23 June procedural voting record, which specifically records approval of a proposal to remove the draft from the agenda.

## Suggested concise report

On 23 June 2026, the Seimas voted by 68 to 16, with 25 abstentions, to remove Draft Resolution No. XVP-1629, “On the June 1941 Uprising,” from its agenda. The draft resolution was therefore not considered or adopted at that sitting.

Prepared 11 July 2026. The Lithuanian quotation above is transcribed from indexed text of the official Seimas website. Because the cited lrs.lt pages were returning 404 errors to the researcher’s UK browser at the time of preparation, the URLs are preserved here for source identification and future retrieval.
