I write to you on behalf of the Conference of European Rabbis, Europe's leading rabbinical alliance representing some 700 Orthodox rabbis in mainstream communities in over 50 European countries. We work on a range of issues, including challenging antisemitism and protecting religious practice. Our aim is to ensure that Europe's Jewish communities can flourish in open and tolerant European societies.

As you will know, plans for the expansion of an existing sports centre on the site of the historic Vilnius Jewish cemetery in Snipiskes has caused great distress within the Jewish communities in Lithuania, as well as across Europe and the entire Jewish world.

Since the onset of Soviet rule, there have been numerous construction projects undertaken on this holy site without proper consultation with the Jewish community in Lithuania and its religious leadership. The approval for the construction of a multi-million-dollar sports centre on this historic Jewish cemetery by your department is a continuation of this trend. The vast majority of Lithuanian Jews, who now predominantly live in the US and Israel, are the descendants of those buried within its grounds. As such, they do not support any construction plans on the site due to their ancestral connections.

The Committee for the Preservation of Jewish Cemeteries in Europe (CPJCE) does not have the authority to, G-d forbid, approve the continued desecration of the cemetery through any further digging, exploration and development - either on or around the cemetery site. On behalf of the Conference of European Rabbis, I want to clarify that the CPJCE lost the authority to liaise with the Lithuanian Government on this vital issue because they did not respond to a summons of the Rabbinical Court, and subsequently do not represent the voice of European Jewry. Let me also be clear that the Conference of European Rabbis no longer maintains a formal affiliation with the group. We therefore urge the Lithuanian Government to cease all communications with the CPJCE and to continue to liaise with the Conference of European Rabbis and other leading Jewish organisations on issues relating to European Jewry.

A Change.org petition started by a member of the Jewish community in Vilnius opposing any further development on this site has now received over 50,000 signatures. Global Jewish leaders from around the world including R' Chaim Kanievsky - a foremost Rabbinic leader in the international Jewish community - have signed up in opposition to the planned development. This should give an indication of the strength of opposition to the proposed desecration of the cemetery.

In 2008, the US House of Representatives passed a motion condemning Lithuania for its "failure to protect the historic Jewish cemetery in Vilnius". On behalf of Europe's Jewish communities, we implore you to learn from the mistakes of the past and to halt all further development plans immediately. Any development on this site would be a profound desecration and a source of shame for Lithuania that would resonate throughout history.

I look forward to hearing from you.

Your Excellency:

The Moetzes Gedolei HaTorah (Council of Torah Sages) of America respectfully conveys its firm opposition to the plan to build a convention center and concert hall over the Old Jewish Cemetery in the Shnipeshok section of Vilnius, and implores you to take immediate steps to prevent this unconscionable desecration.

The Council of Torah Sages of America is a body consisting of a group of senior rabbinical leaders, most of whom serve as deans of Jewish academies where the Talmud and other sacred Jewish texts are studied utilizing "the Lithuanian method" – a highly analytical style of learning developed in the great Lithuanian Jewish academies.

We are deeply troubled by reports of plans to do construction on the site of the Old Jewish Cemetery in Shnipeshok. This must not happen.

The cemetery in Shnipeshok occupies a prominent place in the hearts of Jews the world over. Great sages and scholars, whose piety and leadership are revered still today, and whose written scholarship is studied still today, are buried there. All cemeteries deserve respect; the Old Jewish Cemetery in Shnipeshok deserves special respect.

As a matter of Jewish law it is prohibited to build on the site of a cemetery – not only because such building disturbs the remains of those who are buried in the cemetery, but also because the cemetery is considered hallowed space and building upon it is seen as a desecration of the holy.

Furthermore, burial plots were purchased by individuals whose ownership rights in the graves passed on to their children, and then to their grandchildren and great grandchildren, through the generations. Government has no right to unilaterally confiscate such property for construction purposes.

The Council of Torah Sages joins in the outcry that has been voiced by numerous rabbinic authorities in Israel and across the globe in opposition to the planned construction. There is overwhelming international consensus among religious Jewry that this plan must not be allowed to come to fruition. We further understand that many secular entities and prominent humanitarians have also spoken out against the plan to desecrate the Shnipeshok cemetery, which they rightly see as an affront to human dignity.

Respectfully, but urgently, the Council of Torah Sages of America implores you to use your good offices to block the proposed construction on the site of the Shnipeshok cemetery.

His Excellency President Nauseda:

I write to you to express our opposition to the National Congress Center project, with its plan to construct a Convention Center and Concert Hall over the historical Old Jewish Cemetery in the Snipiskes section of Vilnius. The Old Jewish Cemetery contains the remains of thousands of Jewish residents of Vilnius, with gravestones dated as early as 1487. Amongst those buried in this historic site are some of Vilnius' greatest authors, whose works are studied to this very day by the many thousands of students in the Talmudic academies — established to perpetuate the Lithuanian Talmudic scholarly tradition - here in the United States, in the State of Israel, and the world over.

The Old Jewish Cemetery at Piramónt, in the Shnípeshok (Šnipiškės) district of Vilnius, is the largest in Lithuania. Purchased by the Jewish community with royal permission as freehold property to serve as the eternal resting place for their deceased, it was expanded over the centuries by further adjacent land purchases, with interments in the range of fifty to seventy thousand.

This cemetery has been desecrated and violated repeatedly. Under the Soviet regime, a sports palace was built on the site. After Lithuania gained independence, two apartment complexes were erected there. And now, there is a plan in place to convert the building and a new annex into the Vilnius National Convention and Conference Center.

This plan has been opposed and denounced by Jewish leadership the world over. It represents an affront to the international Jewish community and our historic heritage and is a violation of basic human dignity. It has thus been opposed not only by the Jewish community, but by Senators and members of Congress of the United States.

Our organization – the Union of Orthodox Jewish Congregations of America - is the largest umbrella organization of orthodox synagogues and affiliated agencies and groups in the United States and Canada. Our members, over 400,000 individuals, are located across the United States and the world and are active in all aspects of civic and political life. Our leadership meets regularly with bipartisan members of Congress as well as with White House officials, and we are engaged on an ongoing basis on issues involving domestic and international affairs.



We join in expressing our forceful opposition to this project. We hope and expect that under Your Excellency's leadership a different site will be found for the convention center project, and that Your Excellency's government will dedicated efforts to restoring the dignity of this historic site and of all those interred there.

## Regarding: The Old Jewish Cemetery - Vilnius

The link between the Jews of Lithuania and its land is inextricable. For centuries, many Jews have lived throughout this country and it has been a source of inspiration for wonderful works pertaining to the Torah. The world of yeshivas, which is the breeding ground for the wisdom of the Jewish Torah, was able to establish central 'batei midrash' [Jewish study halls] on Lithuanian soil.

In recent years, remnants of the Jewish community are still being found in certain places in Lithuania. Unfortunately, the remains left behind by Jewish communities are disappearing; I think that this heritage should be preserved, and that it is a source of pride for both the Lithuanian people and the Jewish people.

In the above-mentioned cemetery, which is found on the Viliyah – Neris River, in a region called Šnipiškės, are buried the remains and bodies of tens of thousands of Jews.

I have recently been informed that there was an intention to destroy the large gymnasium that was built on the cemetery and to turn the area into a conference center. This activity will severely damage the remains of the bodies that are found in this holy land. According to Jewish law, this is forbidden in any way. I do not think that there is any Jewish Torah element that has the authority to decide that such a thing is permissible.

As the Chief Rabbi of the State of Israel and as the President of the Chief Rabbinate of Israel, I maintain constant and continuous contact with most of the rabbis in the world, and especially with the leaders among them, and in the opinion of all, it is forbidden to modify the current situation.

I appeal to you to do as much as possible to prevent any harm to the martyrs of Israel and to those buried there and not to descerate this holy cemetery.

I would like to express my gratitude and respect for your work on behalf of others and my appreciation for the values according to which you conduct your policy.

## Opinion and Holy Call

Re: Plans to renovate the building erected in the ancient Vilna cemetery and to turn it into a concert hall

As is known, in the Jewish community throughout the generations Jewish cemeteries – the final resting places of our sages of early generations, venerated as angels –are sacred places to which people come from near and far to pray to our Heavenly Father. As is known, in Jewish cemeteries burial is permanent and disinterment is not allowed even after many centuries.

Jewish law is quite clear and as stated in the *Shulchan Aruch* (*Yoreh Deah* chap. 368, section 1, and *Rema*, ibid) it is forbidden to behave in a light-headed manner in a cemetery e.g. take care of one's physical needs, or eat or drink there or to use it as a shortcut etc., due to the respect to be shown to the dead. The law is clear that if the graves were disinterred, G-d forbid, that place may not be reused for any purpose, as stated in the *Shulchan Aruch* (*Yoreh Deah* chap. 324, section 6) that a grave that has been disinterred may not be used to store grain or wood, nor as a store place for valuables, due to the respect to be shown to the dead (as explained in the *Shach*, subsection 14).

Besides the sanctity of the place, one should know that it is customary in Jewish communities world-wide that family members (or the person himself during his lifetime) purchase the burial plot for the deceased at the full price as a permanent purchase, and as explained in the Talmud (Bava Batra, 112a) it is a disgrace for a righteous person to be buried in a grave which does not belong to him. It is therefore clear and obvious that the place of the graves does not belong to the Community nor is a public area, but is the private property of the deceased and their descendants, whether they are ascertainable or not, and the Community bodies do not have the right to sell it, and if they do so, the sale is ultra vires and invalid. Similarly, if they agreed to the destruction of part of the cemetery, or to the carrying out of renovations in destroyed areas their agreement to the restoration project is ineffective, as it is not their property, and the descendants of those buried in this cemetery may take legal proceedings to ensure that no use be made of the place.

[In addition to the above, there is a real danger that during the renovation works damage may be done to as yet ndamaged graves, or the bones of those buried in graves which have been previously destroyed may be uncovered. Turthermore even if the renovation is done under supervision, it is clear that such a large building needs periodic infrastructure works, and who will supervise these?]

Therefore, for all the above reasons, it is our opinion that according to Jewish Law the sanctity of the cemetery must not be harmed and that even after it has been destroyed in the past it is still consecrated ground, and is also a place that has been stolen from the deceased and their heirs. It is therefore forbidden to further aggravate the transgression and renovate the structure erected over the destroyed graves, and certainly should the area be turned into a place of entertainment, it would be a desecration of its sanctity. Therefore it is obligatory to seal up the existing building and leave it as it is.

Dear Mr. President,

Dear Mr. Prime Minister,

I write to you with a deep personal connection to the heritage of Lithuanian Jews. Many South African Jews are descended from Lithuania, including my own great-grandparents, all of whom were born in Lithuania.

I write to you with a plea that the National Congress Center project, with its plan to construct a Convention Center and Concert Hall over the historical Old Jewish Cemetery in the Snipiskes section of Vilnius, be reconsidered and abandoned. I am astounded that Lithuania would even consider desecrating an ethnic cemetery, and even more so, one of such historical significance.

The Old Jewish Cemetery contains the remains of thousands of Jewish residents of Vilnius from the 16<sup>th</sup> through the 19<sup>th</sup> centuries. Among them are the remains of some of Vilnius' greatest authors, whose works are studied to this very day in Lithuania, in greater Europe, in Israel, and especially by the heirs of Lithuania's Talmudic academies here in South Africa .The Talmudic academies here, in the United States, and in Israel number well over 20,000 students. They study regularly the works of such great scholars as Rabbi Elijah the Gaon of Vilna, R. Zelmele of Volozhin, R. Moshe Rivkes, and R. Abraham Danzig, all of whom were buried in the Old Jewish Cemetery of Vilna.

As is well known, in 1971, under Soviet domination, a Sports Palace was built over a section of the Old Jewish Cemetery. The graves under the Sports Palace were demolished, never to be recovered. The headstones throughout the cemetery were removed (and often used for construction purposes), but hundreds of graves remain – as proven by recent archaeological surveys and underground radar penetration investigation.

One would have thought that this desecration would have been rectified with the establishment of Independent Lithuania in 1900-1991. Instead, the Old Jewish Cemetery, paid for in full and in perpetuity by the Jewish community of Vilnius, was not restored to them. The Sports Palace, now abandoned and an eyesore, should be demolished. The Old Jewish Cemetery should be restored with trees and greenery and dignity, with a proper gate around the cemetery. Let it forever remain a memorial to the vibrancy of Jewish life in

In effect, we are calling for a change of venue of the Congress Center project. Surely there are other appropriate sites in Vilnius for the construction of a Convention Center and Concert Hall that will not involve the desecration of a Jewish historical site, one of the few remaining Jewish sites in Vilnius to have survived the Holocaust.

In 2015, the Deans of the leading transplanted Lithuanian Talmudic academies in the Unites States and Israel, all of them distinguished rabbis and scholars of Lithuanian descent, issued a ban against any further desecration of the Old Jewish Cemetery in Vilnius. They indicated that Jewish law forbids the construction of any public facility over a Jewish cemetery. They called upon the Lithuanian government to restore the dignity of the Old Jewish Cemetery to its former state.

Surely by agreeing to a change of venue, Lithuania will earn the admiration of democracies throughout Europe and indeed the world. It would reaffirm Lithuania's commitment to human rights, and especially to the rights of minorities to maintain the sanctity of their holy sites.
