# MEMORANDUM REGARDING THE ACTION PLAN FOR THE PERPETUATION OF THE GREAT SYNAGOGUE OF VILNIUS AND THE ARRANGEMENT OF ITS ENVIRONMENT

**Vilnius City Municipality**, code 111109233, registered office address Konstitucijos pr. 3, LT-09308 Vilnius, represented by the Mayor of the City of Vilnius Remigijus Šimašius, (hereinafter – the City),

The Jewish (Litvak) Community of Lithuania, code 190722117, registered office address Pylimo g. 4, represented by the Chair Faina Kukliansky, acting under the Community statutes (hereinafter – LJC),

The public institution "Geros valios kompensacijos už žydų religinių bendruomenių nekilnojamąjį turtą disponavimo fondas" (English: Goodwill Foundation for Distributing Compensation for Real Estate Property of Jewish Religious Communities), code 302702699, registered office address is Pylimo g. 4, represented by Acting Director Indrė Rutkauskaitė, acting under the Community statutes (hereinafter – GWF), and supported by GWF founder Andrew Baker, director of the American Jewish Committee for International Jewish Affairs,

in the implementation of the Resolution No XIII-1142 of the Seimas of the Republic of Lithuania of 10 May 2018 "On Designating the Year 2020 as the Year of the Vilna Gaon and the History of the Jews of Lithuania",

in the execution of the Resolution No 786 of the Government of the Republic of Lithuania of 24 July 2019 "On the Approval of the Plan for the Commemoration of the Year of the Vilna Gaon and the History of the Jews of Lithuania in 2020",

### understanding that:

• the Great Synagogue of Vilnius and its facilities is a unique Jewish (Litvak) sacred site. This is a place where the Vilna Gaon Elijah ben Solomon Zalman, whose 300<sup>th</sup> anniversary was celebrated in 2020, worked and created;

- the Soviet government nationalised the Great Synagogue of Vilnius and its facilities in 1940;
- although the Great Synagogue of Vilnius and its facilities were not destroyed during World War II, they were left severely damaged, and in this condition, both the sanctuary and the other buildings could have been preserved and rebuilt. However, the Soviet authorities demolished the Synagogue and its other buildings in 1955–1957 and built a kindergarten in its place, where the Vytė Nemunėlis Primary School was established after the restoration of independence (the school was eventually moved out with the help of the Vilnius City Municipality);
- in 2011, the Government and the Department of Cultural Heritage under the Ministry of Culture of the Republic of Lithuania initiated archaeological research of the Great Synagogue of Vilnius, which allowed discovering more facts about the sacred parts of the Synagogue and its facilities. Today, the research continues from the funds of the GWF;
- several of these discovered archaeological sites (Vilnius Great Synagogue, Mikviai Building) are now owned by the GWF;
- after World War II, the Jewish community in Vilnius and Lithuania declined significantly and is now dying out altogether. There are a very few practising Jews, so there is no need for one more synagogue in Vilnius;
- using the remnants of such an important ensemble as the Great Synagogue of Vilnius for commercial purposes and developing real estate on or adjacent to its territory would be incompatible with the sacred nature of the site;
- the guidelines for the memorialisation of the Great Synagogue of Vilnius drawn up by the International Heritage Advisory Working Group on the initiative of the Jewish (Litvak) Community of Lithuania must be observed. These guidelines do not provide for the restoration of the Great Synagogue of Vilnius, nor the construction of a commercial building, as this would send a false message to the public;
- the aim is to create a memorial square on the territory of the Great Synagogue of Vilnius and its facilities, establishing therein a Jewish Community Centre, which would meet the needs of the Jews of Vilnius and would serve the educational function of the general public, telling about the Great Synagogue and its history;
- in the current climate change environment, the modern city should preserve as much greenery as possible to meet the needs of the Jewish Community Centre and to commemorate the Great Synagogue of Vilnius in a meaningful way.
